ORDINANCE NO. 23-5

**ORDINANCE LEVYING AND ASSESSING PROPERTY TAX FOR
RICHTON PARK PUBLIC LIBRARY DISTRICT,
COOK COUNTY, ILLINOIS**

WHEREAS, the Board of Trustees of the Richton Park Public Library District, Cook County, Illinois, did on the 20th day of September, 2023 pass the annual Budget and Appropriations Ordinance (Ordinance 23-4) for said Library District for the fiscal year commencing on July 1, 2023, and ending June 30, 2024; and

WHEREAS, said Annual Budget and Appropriations Ordinance was duly published as provided by law after its passage;

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Richton Park Public Library District, Cook County, Illinois, as follows:

SECTION 1: That the total sum of one million five hundred three thousand one hundred seventeen DOLLARS (\$1,503,117) composed as follows: The sum of eight hundred seventy-five thousand DOLLARS (\$875,000), being the amount deemed required for the necessary corporate purposes of Richton Park Public Library District, Cook County, Illinois; the sum of seventy-five thousand DOLLARS (\$75,000), being required for the payment of employer contributions of Richton Park Public Library District to the Medicare and Social Security Fund; the sum of sixty thousand DOLLARS (\$60,000), being required for the payment of employer contributions of Richton Park Public Library District to the Illinois Municipal Retirement Fund; the sum of ten thousand one hundred twenty-five DOLLARS (\$10,125), being required for the payment of the professional opinion of an accountant and other auditing expenses from an Audit Fund; the sum of fifty-five thousand DOLLARS (\$55,000), for the purpose of payments due for the purchase of liability insurance, crime coverage, workers' compensation insurance, property damage (fire) insurance, and legal fees for defending or otherwise protecting itself against liability from a Liability Fund; the sum of thirty thousand DOLLARS (\$30,000), being required for the maintenance, repairs, and alterations of library buildings and equipment from a Maintenance Fund; the sum of five thousand DOLLARS (\$5,000), for the purpose of payments due for the purchase of unemployment compensation insurance from an Unemployment Insurance Fund; the sum of three hundred ninety-two thousand nine hundred ninety-two DOLLARS (\$392,992), being required for the payments to retire the principal or pay interest on bonds from a Bonds & Interest Fund, be and the same is hereby levied and assessed upon and against all taxable property within this Library District according to the full fair value as established and ascertained for State and County purposes for the year 2023, and the Board of Trustees of the Richton Park Public Library District having on the 20th day of September, 2023, duly passed and adopted the annual Budget and Appropriations Ordinance for the fiscal year beginning July 1, 2023 and ending June 30, 2024, and said Ordinance having been duly published in a newspaper of general circulation within this Public Library District, this Board finds that the specific purposes and the specific amounts provided for in said annual Budget and Appropriations Ordinance, a copy of which is attached hereto and by this reference made a part hereof, are required to be levied for the necessary purposes of the Richton Park Public Library District.



I further certify that the Richton Park Public Library District requires the sum of \$1,503,117 as is more fully shown in said Tax Year 2023 Levy Ordinance 23-5 and the annual Budget and Appropriations Ordinance to be levied on the taxable property in said District for the year 2023.

I further certify that said Ordinances have not been amended or repealed but remain in full force and effect at this time.
